



MUSIC VIDEO RELEASE FORM

Dear (The licensor/you)

NON-EXCLUSIVE LICENSE TO BROADCAST MUSIC VIDEO

This letter when signed by both you and the Zone Three 6 Network Limited
(The licensee) will constitute an agreement between us on the terms and conditions set below.

1. GRANT OF NON-EXCLUSIVE RIGHTS

1.1. You own and/or control all rights in and to the music video (s) described
In Annexure "A" (The music video). You hereby grant to Zone Three 6 Network
Limited rights in respect of the music video.

1.1.1. To telecast, broadcast, simulcast, narrowcast or transmit the music Video in
perpetuity by means of any network or transmission system now including but not
limited to any terrestrial, satellite or cable systems, as part of the Zone Three 6
Network Limited.

1.1.2. To grant sub-licenses to any third party in respect of the rights granted in Terms of
this agreement which will include the right to syndicate the Channel in part or in the
whole to any broadcast throughout the world.

1.1.3. To cause or permit any performance in public in the music video.

1.1.4. To authorize the editing or the adaptation of the music video.

1.1.5. To use the music video for promotional purposes.

1.1.6. To make mechanical reproductions of the music video for the purpose of Broadcasting.

1.1.7. Zone Three 6 Network Limited shall be entitled but not obliged to exercise the rights granted in clause 1.1. above. The broadcast of the video shall be at the sole Discretion of Zone Three 6 Network Limited. Should Zone Three 6 Network Limited reject a video on the basis that anyone or more of the technical requirements have not been satisfied, then the license shall automatically ceases to apply to such video.

2. YOUR OBLIGATIONS

2.1.0. You will deliver to Zone Three 6 Network Limited:

2.1.1. A master copy of the video on Betacam SP format which shall be of a quality generally accepted in Ghanaian broadcasting industry. Zone Three 6 Network Limited in its sole discretion reject the music video if the technical quality is not of standard to Zone Three 6 Network Limited.

2.1.2. Press material containing photographs, biographies and additional information available about the artist featured in the videos, in order for Zone Three 6 Network Limited to promote the artist on the Channel.

2.1.3. Copies of documentation evidencing your rights to distribute and exploit the music video which shall include copies of agreements concluded with the composer of the music incorporated in the music videos, the owner of the sound recording, the artist performing in the music video and the producers of the music video.

2.2.4. You shall be responsible for any damages to the music videos which may occur before delivery. If the music video is found to be damaged on receipt, Zone Three 6 Network Limited shall immediately notify you and you will supply to Zone Three 6 Network Limited a duplicate video at no additional cost to Zone Three 6 Network Limited.

2.3.5. You will be responsible for all payments due to third parties who participated in the production of the music video including any salaries, fees, royalties or commissions due to artists, performers, directors or producers in respect of the creation and exploitation of the music video. It is specifically recorded that Zone Three 6 Network Limited shall bear no liability in this regard.

3. CONSIDERATION

3.1 You agree that no consideration will be paid by Zone Three 6 Network Limited for the rights granted in terms of this agreement.

3.2 In addition, Zone Three 6 shall not be required to pay any royalties which may be associated with the use of the sound recording featured in the music video or with the broadcast or copying of the music video.

4. WARRANTIES

You warrant that:

4.1.0. You own and/or control all rights in and to the video and are entitled to grant to Zone Three 6 Network Limited the rights set out in this agreement.

4.2.1. The music video and the music and sound recording associated with it, does not infringe the copyright or any other right of any third party.

4.3.2. You hereby indemnify and hold Zone Three 6 Network Limited harmless against all claims and cost including, without limitation, legal fees, damages and expenses arising directly or indirectly out of any breach of any warranty, representation or undertaking given by you Zone Three 6 Network Limited in terms of this agreement.

5. GENERAL

5.1. This agreement contains the complete understanding between the parties and no agreement varying, adding to deleting from or canceling the terms of this agreement or waiving any rights or obligation in terms of this agreement shall be effective unless reduces to writing and signing by both parties.

5.2. This agreement shall be interpreted and implemented in accordance with the law of the Republic of Ghana.

Please sign this letter and the attached duplicate in order to confirm that you understand and accept the terms set out above. Kindly return the signed duplicate to Zone Three 6 Network Limited without delay.
